



The 2022 Annual General Meeting (AGM) of EFCA will be held on **Sunday, 11th September 2022**, subject to a quorum of **140** commencing at **12:30pm** as per the Notice of Meeting dated 14th August 2022.

This Info Pack provides further details regarding the AGM.

In this unprecedented time, the 2022 AGM of our church will be conducted in-person at Zenith Theatre and online through Zoom as we wish to cater for the circumstances of as many of our members as possible. Conducting the AGM this way is far from simple and we anticipate technical challenges. Please pray and bear with us as we plan, organise and execute this AGM.

Procedures

To keep things simple and to minimise the duration of the AGM, we have modified our traditional approach. In particular, please note the following procedural points:

1. **Documents circulated before the AGM is taken as read.** The minutes of the 2021 AGM will not be read out aloud during the AGM (see Annexure A). The 2022 Financial Report will be taken as read and no further presentation will be made during the AGM (see pp 60-79 of the 2022 Church Annual Report (Annexure B).
2. **Questions must be submitted in writing to the Deacons Board at least two (2) days before the meeting, i.e. by Friday, 9th September 2022.** Questions must relate directly to the agenda items. Not all questions may be answered during the AGM. Any

questions not answered will be addressed on a separate occasion or directly with the person.

3. **No other business will be considered during the AGM.** We will follow the set agenda strictly. The wordings of all motions put to the AGM are set out below and will be shown on the slides during the AGM.

We aim to complete the AGM within 60 minutes.

Quorum

A quorum of **140** is required before the AGM can commence.

If quorum is unable to be attained, we will follow the adjournment procedures in our constitution. For clarity, we intent to implement the following procedures:

1. If quorum of **140** is not reached by 1:00pm on 11th September 2022, the Chairman will propose, subject to the consent of members present (in-person and online) to adjourn the AGM to 1:10pm on the same date, 11th September 2022 (the **Adjourned AGM**).
2. If quorum of **140** is again not reached in the Adjourned AGM by 1:40pm on 11th September 2022, the quorum will become 3 as per the constitution.
3. Then, assuming we have the minimum quorum of 3, the AGM will commence.

We ask all members to **please register and join the AGM in-person or online** to ensure we have quorum on the day. If not, it will take considerable time and effort to go through the above procedure.

Registration

The Annual General Meeting will be held at the Zenith Theatre in Chatswood and live on Zoom for online attendance.

All members must pre-register for their attendance, physical and online attendance, prior to the meeting. If you do not pre-register, you would not be able to attend the AGM. Each member has to register their attendance, physical or online attendance, individually.

Pre-registration will open on Sunday 28th August 2022, 9am and will close on Fri 9th September 2022, 5pm.

After registration, you will receive a confirmation email containing a unique link for joining the AGM on 11th September 2022. Please **do not share** this unique link with anyone; **each member has to register their online Zoom attendance individually for a different link to join the AGM.** This is very important. Firstly, because of security. Secondly, because each Zoom login will only be counted once for quorum purpose – this means, for example, if there are 3 members in your household and you login using only one link, we only count one person (i.e. the pre-registered member) for the quorum and this would make it much harder to achieve quorum for the AGM.

Procedure for Passing Motions

Adapting our traditional practice to the new in-person & online mode of AGM, we will adopt the following procedures for each motion:

1. Chairman asks a person to propose and another person to second the motion.
2. Chairman determines whether there is support by a simple majority of members present. Since we are dealing with routine matters and to simplify process, **members are assumed to support the motion unless they indicate clearly otherwise** as follows:
 - In-person: raise their hand and say "I object" or "I abstain".
 - Online: use Zoom chat function and type "I object" or "I abstain".
 - For both, please also mention your name clearly so we can record it properly in the minutes.
3. Motion is carried unless the majority object/abstain.

In-person and online attendees can all participate in this process. We will allow time for the online attendees to respond as it is recognized that there is a "time delay" between what is happening in Zenith Theatre and when that is heard by the online attendees, and vice versa. We ask all members to have patience throughout the process.

How to Propose and Second Motions?

In-person attendee can propose and second in the usual way by physically raising their hand and stating their name if ask to do so.

Online attendees can propose and second a motion by using:

Chat in Zoom. The chat message must contain the person full name (in English or Chinese) and the motion number.

E.g. "[John Chan] propose motion 1", "[John Chan] second motion 1"

To avoid confusion, do not use other Zoom function to show your response. Other methods will be disregarded.

General Info for Online Attendees

You will be able to see the AGM slides and see and hear the speaker online via Zoom.

The video from the in-person AGM is under the name "**EFCA - Zenith Theatre**".

In Zoom, you can **Pin** that video so you can see it full screen. We will also Spotlight that video periodically to make it appears full screen.

Do not use Gallery or Thumbnail View as this will reduce the size of the video.

Please mute your audio.

Questions and Technical Issues

You can use the Chat function in Zoom to ask questions. We will have a number of Zoom host/ co-hosts to help as best as we can.

Health & Safety

Date: 12th September 2021

The quorum required was **152**. As members present (**284** in Total) had reached the quorum, the Chairman called the meeting to order at **12:30pm**. Rev David Tse led the members with an opening prayer.

Agenda items and Minutes

1. Senior Pastor's Sharing

Rev David Tse shared a message - **Reflections on what GOD wants His Church to be like** (1Cor 3:9)

- We are Fellow Workers in God
- God's Field
- God's Building – Architectural word picture

2. Adoption of the Minutes of the AGM 2020

Anthony Ho raised the minor correction on Item 6c of AGM Minutes (English Version) - ... *pursuant to the same rule, 7 positions were to be filled by current deacons offering for re-election*

Victor Li proposed to adopt the Minutes of Annual General Meeting 2020. **Yuna Yang** seconded. There were no objections. The Chairman declared that the motion was carried.

3. Endorsement of the Financial Report 2020/21

Ernest Au-Yeung proposed to adopt the Financial Report 2020/21. **Claudia Fok** seconded. There were no objections. The Chairman declared that the motion was carried.

4. Appointment of the Financial Auditor for 2021/22

Pearl Cheung proposed to adopt the motion to appoint Theway Accounting Services as the financial auditor for 2021/22. **Alan Wu** seconded. There were no objections. The Chairman declared that the motion was carried.

5. Endorsement of the Annual Report 2020/21

- a. The Chairman thanked Ash Lau for his hard effort on designing and producing the annual report and all brothers and sisters who contributed to the report.
- b. **Stephen Yu** proposed to adopt the Annual Report 2020/21. **Felix Tang** seconded. There were no objections. The Chairman declared that the motion was carried.

6. Election of Deacons 2021/22

- a. The Chairman announced that there is one retiring deacon (**Claire Wang**).
- b. The Chairman reported that, pursuant to Rule 8.4.2 of the Constitution, the retiring Board of Deacons had determined that 11 positions are to be filled at this Annual General Meeting. And pursuant to the same rule, 7 positions were to be filled by current deacons offering for re-election and 4 positions were to be filled by nominations from the congregation.
- c. The remaining 7 current deacons (**Alvin Chan, Arthur Cheng, Eppie Cheng, Darwin Hou, Joseph Hui, Louise Law, I-van Leong**) would seek re-election.
- d. Since there were only 3 new deacon nominations (**Andres Wong, Dennis Law, Vivien Zheng**) from the congregations, pursuant to Rule 8.4.7.3 of the constitution, all 7 current deacons offering for re-election and 3 new deacons offering for election were deemed to be elected.

7. Appointment of Delegates to the Fellowship of Evangelical Free Church of Australia 2021/22

- a. **Andres Wong, Leon Lai and Michael Law** would be stepping down.
- b. **Humphrey Chan, Regina Lee and Ruby Li** would seek re-appointment.
- c. There is no new FECCA Delegate candidate for 2021/22 from the congregations.
- d. **Paterson P Kwan** proposed to appoint Humphrey Chan, Regina Lee and Ruby Li as Delegates to FECCA for 2021/22. **Ash Lau** seconded. There were no objections. The Chairman declared that the motion was carried.

With no further business, the Chairman invited all newly elected deacons and appointed delegates for a commissioning and closing prayer by Rev David Tse. The Chairman closed the meeting at **1:22pm**.

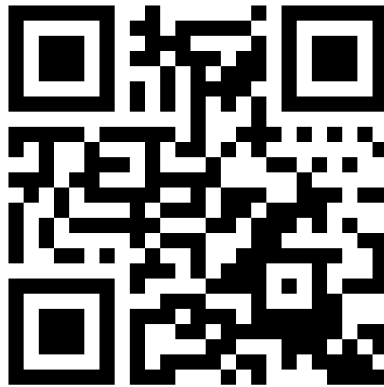
